IV. ORDER OF BUSINESS:

Meeting called to order by Marianne Bond.

A. READING OF MINUTES:

The minutes from the 06/17/17 meeting were posted online and emailed to all members with the meeting reminder. A motion was made by Brie Butler to accept the minutes from the meeting and this motion was second by Jessica West.

B. CHAPLAIN'S REPORT: Marissa Davis advised that several cards were sent to members in regards to deaths or illnesses that had affected them. The association received a thank you card back from the family of Latisha Allen for the thoughts that were sent during their loss. Marissa mentioned several recent line of duty deaths in which condolence cards were sent, such as Corrections officer, Megan B. C. TREASURER'S REPORT: Brie Butler reported the following balances:

1. **Current Balance:** \$14,782.34 in checking, \$7,052.25 in savings.

Brie reported that several items have been factored into the report this quarter, such as: conference income, membership dues, polo shirt revenue, expenses 69.61 flowers, 250.00 conference for next year, 1054.52 t shirts, raffle prizes, office expenses 177.63, promotional pins 133. The Banquet is the biggest expense this year. The hospitality room will be open in evening with snacks and drinks that have been provided by the association.
